Local Lodge Special Called Nomination Meeting Q and A

Subject: IAM Air Transport District Lodge 142, Local Lodge Special Called Nomination Meeting Question and Answer

We have responded to a few questions related to your Local Nomination meetings for the DL 142 Elected office elections, taking place this Friday, September 23, 2022. If you are unsure where your nomination polling site is, please see the **Notice of Election** mailed, if for some reason your mailer did not arrive, you can go to our DL 142 website, read the **Notice of Election**, click either link to see the website and/or go to your Local Lodge Nomination location.

Q: Is this considered a regular Local Lodge meeting?

Answer: NO. This is a Special Called Nomination Meeting for the sole purpose of opening the Local Lodge polls on September 23, 2022, for members to **nominate candidates** for the IAM Air Transport District Lodge 142 offices as stated in the **Notice of Election** sent on September 2, 2022 and posted on the DL 142 website <https://atd142.org>. There will be no motions entertained and no transacting any business of the Lodge, except membership candidate nominations.

Q: Is the Local Lodge required to have a quorum?

Answer: There is **no** meeting quorum required to open a LL Nomination Meeting. To open the Nomination Meeting for the **6:00 a.m. to 8:00 a.m.** and **6:00 p.m. to 8:00 p.m.** to accept the DL 142 candidate nominations, requires only one Local Lodge Executive Board member and an election teller. A minimum of one of the IAMAW constitutional officers as outlined in the IAM Constitution in Article "B", Section 1, lines 1-4 and per your Local Lodge bylaws.

Q: Who may Nominate?

Answer: As stated in the District Lodge 142 **Notice of Election**, members in good standing may nominate a candidate(s).

Q: What if a member who comes to nominate is not a member or is not on the LL membership roster?

Answer: Allow the Nomination to be accepted as a Provisional Nomination for the Election Inspectors of the DL 142 to verify. Be sure to place it in an envelope with the person's name, address and reason they believe they are eligible. Any person whose nomination is not accepted, will be notified via United States Postal Service (USPS) with the reason.

Q: What if the District Lodge 142 Candidate Nomination Form has more candidates nominated than required for Offices as shown on the **Notice of Election**?

Answer: The Local Lodge will receive further information on holding a LL Endorsement Vote on Oct 28, 2022 as seen on the **Notice of Election**. Additional instructions will soon follow once the information has been received by the IAM Air Transport District Lodge 142 Secretary-Treasurer.

Q: I do not know or have my membership card number and am not on the Local Lodge membership roster, can I still nominate?

Answer: Yes, you may Nominate, your membership card number or employer and employee ID allows you to nominate, understanding **you must either pay your initiation/reinstatement fees or have dues deduction application on file**. If you're not on the membership eligibility roster at your Local Lodge, you will be allowed to Nominate Provisionally. Meaning your Nomination will move to verification process by the DL 142 Election Tellers.

Q: I want to sign a IAM membership dues application with my Local Lodge, where would I find this at?

Answer: You can reach out to your Local Lodge shop steward or go to the IAM Air Transport District Lodge 142 website link to find your local lodge and click the QR code with your smart phone or click the link, to sign-up.
