1	AGREEMENT
2	
3	THIS AGREEMENT entered into this day January 15, 2023, in accordance with the provisions
4	of the Railway Labor Act, by and between MENZIES hereinafter referred to as the "Company"
5	and the INTERNATIONAL ASSOCIATION OF MACHINISTS AND AEROSPACE
6	WORKERS, DISTRICT 142, AFL- CIO, hereinafter referred to as the "Union."
7	
8	

1	ARTICLE 1
2	PURPOSE OF AGREEMENT
3	
4	A. The purpose of this Agreement is, in the mutual interest of the Company and of the
5	employees, to provide for the operation of the services of the Company under methods which will
6	further, to the fullest extent possible, the safety of air transportation, the efficiency and quality of
7	customer service, and the continuation of employment under conditions of reasonable hours, proper

compensation and reasonable working conditions, all in accordance with the provisions of this Agreement. It is recognized by this Agreement to be the duty of the Company and of the employees

to cooperate fully, both individually and collectively, for the advancement of that purpose. To

further these purposes, the Company or the Union Representative may request a conference or a

meeting at any time to discuss and attempt to resolve any condition that may arise under the

application of this Agreement.

B. No employee covered by this Agreement will be interfered with, restrained, coerced or discriminated against by the Company, its officers or agents, because of membership in, or lawful activity on behalf of the Union. Neither the Company nor the Union shall discriminate against any employee or applicant for employment because of race, creed, color, national origin, disability, age or sex.

19 C. It is understood wherever in this Agreement employees or jobs are referred to in the 20 male gender, it should be recognized as referring to both male and female employees.

ARTICLE 2

SCOPE OF AGREEMENT

2 3

4 A. The Company agrees all work performed by employees in the collective bargaining unit 5 hereinafter defined and generally recognized as mechanical inspection work, mechanic's work, 6 performed in and about Company shops and other Company facilities, including, but not limited to, 7 mechanical work involved in dismantling, overhauling, repairing, fabricating, assembling, welding, 8 painting and radio equipment, electrical systems, heating systems, hydraulic systems and machine tool 9 work in connection therewith, and including the dismantling, repairing, assembling and erecting of all 10 machinery and mechanical devices and automotive and building maintenance and repair work, the 11 work of store clerks, line servicemen, the work involving the moving of aircraft, supplies, refueling of 12 aircraft and automotive equipment, and janitorial work as coming under the jurisdiction of the 13 International Association of Machinists and Aerospace Workers and is covered by this Agreement.

The parties agree that the Company shall have the right (1) to continue to contract out work heretofore customarily contracted out; and (2) contract out any work when the Company's facilities are inadequate or personnel are not sufficient or reasonably available, or where employees who are reasonably available do not have the experience and ability to satisfactorily perform the work required. The Company will inform the Union of its decision to subcontract work under number (3) above and will be willing to meet to give reasons for such action if the Union requests it. The Company shall give at least seven (7) calendar days' notice before commencing any planned project work.

B. The collective bargaining unit covered by this Agreement shall consist of all employees engaged in the maintenance, repair, modification and servicing of aircraft and accessories, including automotive, stores and building maintenance employed by the Company.

C. It is recognized that the nature of the Company's operation is such as to require the employment of regular part time employees to perform specific jobs which arise and to meet peak workloads which occur. It is not the intent of the Company to employ regular part time employees for the sole purpose of avoiding the employment (or continued employment) of regular employees for whom full time work requirements exist under regular work schedules, or avoiding other provisions of this Agreement as they apply to regular full time employees.

Regular part time employees will be scheduled to work for not less than two (2) hours nor more
than eight (8) hours in any one day. The workday for part time employees shall be the twenty-four (24)
hour period commencing at midnight on any day. Part time employees shall be subject to all provisions
of this Agreement, including Schedule "A", except Article 5- Seniority, Article 7- Hours of Service,

except that Section D, paragraph 3, as it applies to a job bid shall be applicable; Article 8 - Overtime
 and Holidays, except that paragraph D as it pertains to premium time shall be applicable; Article 10 Vacancies and Bidding, Article 15 - Sick Leave, Article 16 - Insurance Benefits, Alticle 17 Vacations, Article 20 - Leaves of Absence, and Article 23 - Pension Plan.

5 No regular full-time employee of the Company will be permitted to participate in part time work 6 as a part time employee during any week in which such employee works his regular schedule or 7 receives pay under any other provisions of this Agreement.

8 Regular full-time employees who are laid off for lack of work and who advise the Company in 9 writing at the time of layoff of their desire for such part time employment as may become available in 10 the classification from which such employees were laid off, will be given preferential consideration for 11 such part time employment so long as such employees retain their seniority in accordance with the 12 provisions of this Agreement. Regular full-time employees who elect to bid into a part time position, 13 seniority permitting, shall receive the wages, hours and working conditions of part time employees. 14 "Seniority permitting" means a full-time employee who voluntarily reduces himself or herself to part-15 time status will be placed in the part-time seniority list at the level earned based on Company date of 16 hire and will not be eligible to bid for full-time status for twelve (12) months. However, should an 17 employee decline to accept such part-time work when offered, he shall be given no further 18 consideration for such employment unless and until he shall have once again expressed in writing his 19 desire for part time work.

20 Provided there are no regular full-time employees in a laid off status who are subject to recall 21 provisions of this Agreement, part time employees who meet the Company's qualifications will be 22 given preferential consideration for permanent jobs which may become available within their 23 classification before so-called "outsiders" are hired. Should a part-time employee fail to accept regular 24 full-time employment, the Company shall be under no obligation to again offer such employment. All 25 regularly scheduled part time vacancies shall be posted for bid by seniority.

D. Employees covered by this Agreement shall be governed by all Company rules, Regulations and orders previously or hereafter issued by proper authorities of the Company which are not in conflict with the terms and conditions of this Agreement. The rules in effect on the date of this Agreement are attached hereto. Copies of the rules established in the future will be distributed to employees prior to becoming effective.

E. To facilitate flexibility in adapting to customer schedule changes when such changes affect scheduled shifts, the Company will provide the affected employees with forty-eight (48)

hours advance notice of all changes in regularly scheduled shifts of one (1) hour or less. Full bumping
 rights will apply if an employee so chooses.

F. To facilitate vacation and other ad hoc open shifts, the Company will be allowed to utilize
GSE Mechanic(s) from ORD, Station 403 for periods of up to thirty days at normal hourly rates and all
other benefits apply.

1	ARTICLE 3
2	STATUS OF AGREEMENT
3	
4	A. This Agreement supersedes any and all agreements existing or previously executed
5	between the Company and any Union or individual, affecting the class of employees covered by this
6	agreement.
7	B. All provisions of this Agreement shall be binding upon the successors or assigns of the
8	Company.

1	ARTICLE 4
2	CLASSIFICATIONS OF WORK
3	
4	A. Vehicle Mechanic:
5	The work of a vehicle mechanic shall consist of any and all work generally recognized as mechanic's
6	work in and about Company shops, buildings or facilities. This includes work contracted by owners or
7	persons authorized by owners to contract the work of the Company, whether in company shops,
8	buildings or not. Mechanic's work includes but is not limited to, the dismantling, repairing, painting,

9 repairing, fabricating and erecting of machinery, mechanical devices, automotive equipment, and
10 building maintenance. Building maintenance shall include maintaining, repairing, altering and
11 construction of building and equipment including such work as carpentry, painting, masonry, plumbing,
12 electrical, maintain fire equipment and repair work.) A mechanic may be required to give "on the job"
13 instruction to an employee of the same classification. A Vehicle Mechanic must possess a valid driver's
14 license and is responsible to report to the Company whenever he/she does not hold a valid driver's
15 license.

B. Gauger:

16

Under a minimum of guidance, direction and instruction from supervision, lead and other experienced 17 18 personnel will receive, store, transfer and dispense petroleum products in accordance with established 19 procedures and quality control; perform preventative maintenance on facilities, equipment and 20 systems; and, as required, perform any ground handling operations associated with customer aircraft 21 operations. As directed by supervision, will provide instruction, guidance and assistance to employees 22 in lower rated classifications. Work performed shall consist of, but not limited to, receive, store, 23 transfer and dispense petroleum products at all storage facilities in accordance with established 24 procedures and quality controls; perform fueling operations on assigned aircraft in accordance with 25 established procedures, methods and operations policies exercising established quality control and 26 safety guidelines; procure daily, weekly and monthly petroleum product inventories as required. 27 Prepare and process required documentation related to the work performed; perform necessary duties 28 required in accordance with facility housekeeping and safety requirements such as, but not limited to, 29 cutting weeds and routing painting.

Must possess a valid driver's license and as required, airport facility driver's license and/or permit required as a condition of employment. Where lifting is required, the employee must be able to do the essential functions of the job. Required to pump, visually inspect, clean fuel pits, and provide auto gas and diesel functions as necessary. C. Lead Pipeline Technician:

2 1. The work of a Lead Pipeline Technician shall consist of and include the leading and 3 directing of other Pipeline Technicians. He shall be familiar with the duties of Pipeline Technicians 4 and shall be the working leader of his group. He shall not lead or direct more than ten (10) other 5 Pipeline Technicians. There shall be no reductions in current leads. He shall be responsible for reporting 6 known delays, accidents and incidents to the appropriate management personnel. A lead Pipeline 7 Technician must possess a valid driver's license, airport facility driver's license and/or permit required as a 8 condition of employment and is responsible to report to the Company whenever he/she does not hold a 9 valid driver's license.

10 D. Pipeline Technician:

11 Maintain and repair, including major overhaul, all tank farm and storage facility equipment located at 12 the O'Hare Field Operation. Gauger's will support Pipeline Technicians in strapping of the fuel storage 13 tanks as needed in order to ensure safety. Periodically inspect equipment to determine and/or to 14 perform the repair and maintenance work necessary to prevent functional breakdowns. Determine 15 methods and sequence of operations, dismantles, diagnoses trouble, repairs, mechanical services, 16 reassembles, installs, tests, and calibrates where applicable such equipment as, flow meters, 17 electrically operated valves, high and low level shutoff valves, pressure control valves, pumps, motors, 18 liquid level gauges, etc.

May be required to work on hydrant, loading rack and calibration station fittings, as they pertain to thefunction of the above-mentioned vehicles.

Clean and repair locks for facility lockup system. Perform major repair on all fire protection equipment. Must have a valid driver's license and as required, airport facility driver's license and/or permit required as a condition of employment. Where lifting is required, the employee must be able to do the essential functions of the job.

E. Head Operator:

Coordinates and monitors the receiving, storing, transferring and dispensing of petroleum products at all storage facilities in accordance with established procedures and quality controls. Responsible for the compliance of all quality assurance procedures at primary storage. Inventory daily, weekly and monthly petroleum products as required. Prepare and process required documentation relate to the work performed. Responsible for dispatching work assignments to a group engaged in fuel system maintenance, aircraft servicing and related function. Ensures proper utilization of personnel and equipment and imparts current or new occupational knowledge to workers within the classification of Gauger and Pipeline Technician.

- Responsible for the operation of fire/safety control systems associated with all storage facilities. Performs
 the necessary duties required in accordance with good housekeeping and safety practices.
- Must have a valid driver's license and as required, airport facility driver's license and/or permit required as a condition of employment. Where lifting is required, the employee must be able to do the essential functions of the job.
 - F. General:

7 1.Leadmen shall not have the authority to hire, discharge, discipline or approve matters relating
8 to wages or working conditions.

- 9 2. The Company will select trainers to be paid an additional seventy-five cents (\$.75) per hour
 10 for the day as training is required. While training, trainers will perform all duties of their regular
 11 classification in addition to the training tasks.

1	ARTICLE 5
2	<u>SENIORITY</u>
3	
4	A. Seniority as used throughout this Agreement shall be defined as the length of service for
5	which an employee received credit in any classification covered by this Agreement with this Company.
6	The definition shall include the ability to perform the required work on the job in a satisfactory manner
7	and shall accrue from the date of entering a classification as a regular assignment. Seniority shall be
8	applicable to all classifications covered by this Agreement.
9	B. The principle of seniority shall apply in the application of this Agreement in all reductions
10	or increases of the work forces, preference of shift assignment when a vacancy occurs, vacation period
11	selection in bidding for vacancies or new jobs, and all promotions, demotions or transfers involving

selection, in bidding for vacancies or new jobs, and all promotions, demotions or transfers involving the classifications covered by this Agreement. All shifts, days off and work assignments shall be open for bidding for all classifications bi-annually at minimum in between the months of March and April and again between the months of September and October. Every effort should be made to align bid periods in 6-month time frames pending operational priorities.

As business situations dictate, additional job bids may be required. A grid system bid sheet for shift preference for each classification shall be utilized to fill all vacancies which arise between the annual bid. No premium pay shall be paid to any employee as a result of his being awarded a change in schedule for which he bid.

20 C. Employees will be considered as probationary employees for the first ninety (90) calendar 21 days of employment and there shall be no responsibility on the part of the Company for the re-22 employment of probationary employees if they are laid off during this period. If retained after the 23 probationary period, which may be extended an additional thirty (30) calendar days in individual cases 24 by the giving of written notice to the Union before the end of the specified probationary period, the names of such employees shall then be placed on the appropriate seniority list as of his date of hire. In 25 26 instances where the Company extends an individual's probationary period of an additional thirty (30) 27 calendar days, the written notification to be provided to the Union will also include the reasons for the 28 extension.

Should the Company at its discretion establish a new job classification or make a substantial change in an existing classification, a job description and proposed rate will be submitted to the Union. Rates for such new classifications and/or descriptions shall be in relation to and compatible with the existing rate structure. If the Company and the Union are unable to agree upon any such proposed rate and/or description, the Company shall install the description and classification and apply the rate 1 proposed; provided however, the appropriateness of any such rate and/or description shall be subject to review under the grievance procedure hereinafter set forth, including arbitration.

3 D. Seniority Lists. Seniority lists shall be corrected on November 1 of each year and posted on 4 December 1 of each year. The employees shall be allowed thirty (30) calendar days after posting to 5 correct any errors appearing thereon. A corrected list will be prepared within thirty (30) calendar days 6 thereafter. Errors are to be given to the Company in writing and a copy of the posted seniority list and 7 amended seniority list will be furnished to the Local Committee Chair. Any dispute as to seniority 8 listing shall be handled by the grievance procedure, except in cases of employees hired or entering a 9 job classification on the same date where Company seniority shall govern. Where employees have the 10 same start date with the Company, the last four (4) digits of the Social Security number will be used to 11 determine the higher seniority.

12 Seniority lists shall show employee's last name, first name, original date of hire by job 13 classification, present job classification, by title, time spent in covered classifications, including 14 employees on Military Leave of Absence and employees promoted to supervisory positions. The word 15 "hired" shall be defined as the first day worked for which pay was received.

A separate part time seniority list shall be maintained for part time employees. Part time 16 17 employees may exercise their seniority only for purposes of bidding into full time jobs in their 18 classification (which will be determined by most senior qualified), to higher rated jobs for which they 19 are qualified, and to regular scheduled part time positions, reduction in force and recall after layoff. 20 Regular scheduled part time employees shall be permitted to bid once per year by a grid system for 21 regular scheduled part time positions by seniority. Reasonable efforts will be made by the Company to 22 distribute part time work hours as evenly as possible among part time employees.

23 E. Employees who are promoted after the date hereof to supervisory positions outside the 24 bargaining unit covered under this Agreement shall continue to retain and accrue seniority for a 25 maximum of one hundred and eighty (180) days. In the event any such employee is returned to the 26 bargaining unit by the Company or voluntarily desires to return to the bargaining unit during such one 27 hundred and eighty (180) day period, he shall be entitled to exercise both his retained and accrued 28 seniority. If they are retained on the job after the one hundred and eightieth (180th) day, their names 29 shall be removed from the seniority lists. During this one hundred and eighty (180) day period, the 30 employee shall maintain his good standing membership in the Union.

F. Loss of Seniority An employee will lose his seniority status and his name shall be removed from the seniority list under the following conditions:

1. He quits or resigns.

2. Discharged for just cause.

3. He does not inform the Company in writing by registered mail or telegraph of his intention
 to return to service within three (3) working days after day of sending a notice offering to reemploy
 him after a layoff.

5 4. He does not return to the service on or before a date specified in the notice from the 6 Company after a layoff, which date shall not be prior to the (10) working days after receipt of such 7 notice, provided that subdivisions (3) and (4) of paragraph F shall not apply to offers of temporary 8 work. Any notice provided in this paragraph shall be by certified mail (return receipt requested) to the 9 employee at his last address filed with the Company. A copy of notices of recall sent by the Company 10 will be provided to the Local Committee Chair.

5. He fails to return to work after or at the end of an authorized leave of absence.

6. He is laid off and does not return to work for a period of three (3) years. If hired after
December 1, 1995, and is laid off and does not return to work for a period of one (1) year.

7. Engages in gainful employment while on leave of absence, except when selected by theUnion to perform full-time Union work.

8.A full-time employee who voluntarily reduces himself to part-time status will be placed in
the part-time seniority list at the level earned based on Company date of hire and will not be eligible to
bid for full-time status for twelve (12) months. Paragraph F(l) will apply regarding full-time seniority.

9. A part time employee who is not carrying a bid line and is unable to meet the work
schedule requirements will lose their active employment status. Minimum work schedule requirements
are defined as the employee must be able to work at least twenty (20) hours per month.

10. Any employee absent from work for any reason for one (1) year will be separated subject to state and federal law. In the event the employee returns before the expiration of the one (1) year period, they must remain actively at work for a period of six (6) months before being eligible for another one (1) year period. Should the employee be off work again within the six (6) month period, time lost will continue to count towards the original one (1) year period.

27 28 11. An employee who voluntarily reduces himself, including bidding for a lower classification job, except for employees who hold lead positions who by bidding give up such lead designation, shall have his name removed from the higher classified job and lose all seniority and pay credit in such classification.

32 G. Reduction and Increase of Working Force. Whenever the number of employees in any 33 classification is to be reduced, the reduction must be by classification, in the reverse order of seniority, in

1 the jobs to be reduced. An employee who is given notice that he is to be reduced, or an employee who is 2 being displaced by another employee, must displace the least senior employee in the classification who is in 3 a job for which the displacing employee is qualified, seniority permitting. The employee's Company date of 4 hire will be used as the criteria to place him in the part time seniority list. The employee must n o t i f y the 5 Company on the next workday that he wishes to displace another employee which he is qualified to 6 displace. An employee not n o t i f y i n g the Company will be considered as electing to go on laid off 7 status. He may not displace into a classification in which he does not hold seniority. An employee must 8 displace in his highest classification before proceeding to the next lower classification. Any qualification 9 disputes will be grounds for grievance procedure (Refer to Article 10, Section E). Reductions of force in the 10 mechanical and technical classifications (Lead Mechanics and Vehicle

11 Mechanics) shall occur as set forth above. However, employees reduced in the classification of 12 Lead Mechanic shall have the right to bump into the classification they are leading, based upon their 13 cumulative seniority in that classification and the related lead classification.

14 1. Ten (10) workdays' notice or pay therefore, at the Company's option, will be given to 15 employees to be reduced before such reduction in force is made, and a copy of such notice will be 16 furnished to the employee and the designated Local Union representative.

Where there is temporarily no work because of an Act of God, circumstances over which the
 Company has no control, or work stoppages and strikes by employees of companies which MENZIES
 AVIATION performs work for, it shall not be considered a normal reduction in force and subject to
 this provision.

2. The restoration of forces for all classifications will be by seniority, the most senior 22 employees reduced or laid off to be returned first. Any employee reduced from a classification due to a 23 reduction in force and refusing to accept the first job in the highest classification for which he is 24 qualified, shall have his name removed from the seniority list for that classification. All laid off 25 employees with seniority status shall be recalled for available positions before the hiring of new 26 employees, provided that the recalled employee has the qualifications for the required position.

1 **ARTICLE 6** 2 UNION SHOP 3 A. As a condition of employment, all employees covered by this Agreement shall, within 4 ninety (90) days after their date of hire or the effective date of this Agreement, whichever is later, 5 become members of the Union and remain in good standing in the Union during the term of this 6 Agreement. 7 B. The Company will, within three (3) working days after receipt of notice from the Union, 8 discharge any employee who is not in good standing in the Union as required by paragraph A above. 9 The term "good standing" shall not include more than the obligation to pay all periodic dues and 10 initiation, or reinstatement fees uniformly required. 11 C. Upon receipt of a signed authorization of the employee involved, the Company shall deduct 12 from the employee's paycheck the initiation or reinstatement fees and dues payable by him to the 13 Union during the period of said authorization. 14 D. Deductions shall be made on account of initiation or reinstatement fees from the first paycheck of the employee after receipt of the authorization. Deductions shall be made on account of 15 16 Union dues from the first paycheck of the employee in each month. 17 E. Deductions provided for in paragraph B shall be remitted to the Financial Secretary of the 18 Union no later than the tenth (10th) day of the month following the deductions made in the previous 19 month. The Company shall furnish the Financial Secretary of the Union monthly, with a record for 20 those for whom deductions have been made and the amount of the deductions. In the event a deduction 21 is not made on one (1) or more consecutive payroll deduction dates due to lack of earnings or 22 insufficient earnings by the employee, then on the next regular payroll deduction date that employee 23 has sufficient earnings, a double deduction shall be made and deductions each subsequent payroll 24 period until such employee is in good standing. 25 F. The Union agrees that it will indemnify and save the Company harmless against any and all 26 claims, demands, suits or any other form of liability that shall arise out of or by reason of action taken

In consideration for this save harmless and/or indemnification clause, the Company agrees that the Union shall maintain the exclusive right to defend, settle, mitigate damages, litigate and/or take whatever action is necessary or it deems proper with respect to a person who sues the Company for claims for which the Company is entitled to indemnification by the Union, through attorneys of its own choosing and at its own discretion, but in any event, if the Company unilaterally determines that it desires attorneys to represent it in defense of such actions, it shall do so at its own cost and not at the

cost of the Union. It is further agreed that the Company shall promptly notify the Union of any such
 action when and if filed and the Union shall, at its own option, defend such actions and/or settle under
 the circumstances above described.

This authorization and assignment will be effective and irrevocable for a period of one (I) year from this date, and up to the termination date of the current collective bargaining agreement, whichever occurs sooner. It shall continue in full force and effect for yearly periods beyond the irrevocable period set forth above, and each subsequent yearly period shall be similarly irrevocable unless revoked by me within fifteen (15) days after any irrevocable period hereof. Such revocation shall be affected by written notice, sent by certified or registered mail, return receipt requested to the Company and the Union within such fifteen (15) day period.

1	ARTICLE 7
2	HOURS OF SERVICE
3	
4	A. Eight (8) consecutive hours, exclusive of a lunch period, shall constitute a normal day's
5	work. The work week begins on Friday and ends on Thursday consistent with Company's payroll
6	schedule.
7	B. The work week begins on Friday and ends on Thursday consistent with
8	MENZIES AVIATION Payroll schedule. Forty (40) hours of work consisting of five (5) eight (8) hour
9	days of work, scheduled consecutively within a seven (7) calendar day period, shall constitute a normal
10	workweek. Scheduled days off shall be consecutive within each employee's workweek. It shall be the
11	Company policy to prepare and post ten (10) days (or such lesser period as is practicable) in advance
12	of the effective date, a work schedule which, to the extent practicable and consistent with the safe and
13	efficient operations of the business, provides for the following:
14	(1) Regular days of work and regular days off each workweek for individual employees,
15	consideration being given to senior employees in the assessment of regular days off, and;
16	(2) Regular shift assignments for individual employees, consideration being given to senior
17	employees in originally making such assignments. It must be recognized that in order to meet airline
18	schedule demands, some employees may regularly be scheduled on more than one (1) shift during a
19	regular workweek. The practice will not be to rotate shift assignments.
20	The Company will make every effort to hold to a minimum (and will expect employees to do
21	the same) changes in individual shifts and daily schedules due to absenteeism, employee turnover,
22	flight diversions, flight cancellations, charter flights, etc.
23	C. Employees working on an eight (8) hour shift basis will receive a thirty (30) minute lunch
24	period on each shift during working hours, with pay.
25	(1) Any shift starting at or after 5:00a.m. will be recognized as the first or day shift, and the
26	one-half $(1/2)$ hour lunch period will be regularly established during the fifth (5th) hour of the shift.
27	(2) Any shift starting after 12:00 p.m. will be known as the second shift, and the one-
28	half $(1/2)$ hour lunch period will be regularly established during the fifth (5th) hour, and any employee
29	working the second shift will be compensated with fifty cents (\$.50) per hour in addition to his base
30	rate.
31	(3) Any shift starting after 8:00p.m. will be known as the third (3rd) shift, and the one-

half (1/2) hour lunch period will be regularly established during the fifth (5th) hour, and any employee
 working the third (3rd) shift will be compensated with fifty-five cents (\$.55) per hour in addition to his
 base rate.

4 (4) Any employee scheduled to work a combination of shift start times during a pay
5 week (i.e., employee scheduled to work day shift two days and midnight shift three days, for example)
6 will be compensated with sixty cents (\$.60) per hour in addition to his/her base rate for all hours
7 worked.

8 D. Except on his regularly scheduled days off, no regular employee will be called to work or be 9 required to report for work for a work shift less than eight (8) hours or pay therefore, except (1) where 10 recalled after completing a regular shift of eight (8) hours or more, or (2) to complete a regular shift, 11 the first portion of which was paid in accordance with the overtime procedure. Employees regularly in 12 the service of the Company will be considered as required to report for eight (8) hours work on their 13 regularly scheduled workdays, unless notified by the Company before the close of regular scheduled 14 shift or sixteen (16) hours before the start of their regular shift, whichever is shorter. In instances 15 where there will temporarily be no work because of an Act of God, or circumstances over which the 16 Company has no control, an employee not so notified will receive four (4) hours work or pay at his 17 regular hourly rate. In instances where there will temporarily be no work because of a work stoppage 18 or strike, employees will be paid only for hours actually worked. In all other instances where no such 19 notice is given, an employee will receive eight (8) hours work or pay; however, any employee called to 20 or required to report to work on his scheduled day off will receive a minimum of four (4) hours' work 21 or pay at the applicable rate.

- F. All employees will be granted a ten (10) minute rest period during the first half of their shift and a ten (10) minute rest period during the second half of their shift without loss of time for the purpose of relaxation, smoking, etc. and a five (5) minute wash-up period prior to quitting time.
- G. Employees who, because of the requirements of the service, are requested to start their lunch period prior to the fifth (5th) hour of their shift or after the fifth (5th) hour of their shift, will be allowed a thirty (30) minute lunch period as close to the regular lunch period as possible and will be paid for same at straight time rate. Every effort will be made to allow the employees their lunch period within the limits of the fifth (5th) hour.

ARTICLE 8 OVERTIME AND HOLIDAYS

If overtime is necessary, it will be filled with the most junior qualified person. Additionally, the Company will meet with the union to discuss methods for providing the needed employees for mandatory overtime situations. NOTE: MENZIES AVIATION will continue with current OT procedures.

A. Overtime rate of time and one-half (1½ X), computed on an actual minute adjusted to the nearest tenth of an hour basis shall be paid for all work performed in excess of eight (8) hours in any one day, for all work performed either in advance of or after regularly scheduled hours and for the first eight (8) hours worked on one of two (2) regularly scheduled days off each workweek. In the event an employee works thirty (30) minutes or less after a scheduled shift of eight (8) hours, overtime he will be paid to the nearest tenth (10th) of an hour. Overtime work must always be approved by a supervisor before it is performed.

15 B. Overtime rate of double (2X) time shall be paid for all hours in excess of the first eight (8) 16 hours worked on one of the two (2) regularly scheduled days off in each workweek, for all time 17 worked on the second regularly scheduled day off in a workweek if the first regularly scheduled day 18 off has been worked, and for all time worked in excess of twelve (12) hours in any twenty-four (24) 19 hour period. For overtime purposes, the twenty-four (24) hour period shall begin with the starting time 20 of the employees' regularly assigned shift and shall continue for twenty-four (24) hours thereafter. 21 Relief from duty under this paragraph shall not be considered as absorption of overtime under 22 paragraph G of this Article.

C. Notwithstanding anything to the contrary in any other provision, an employee who works only seven (7) hours as a result of a time change from standard time to daylight savings time will be given the option of going home after seven (7) hours or working another hour at straight time pay. An employee whose timecard reflects nine (9) hours work as the result of a time change from daylight savings time to standard time will be paid for eight (8) hours straight time pay and one (1) hour at the overtime rate.

D. Employees covered by this Agreement will observe the following scheduled holidays to include: NEW YEAR'S DAY, NEW YEAR'S EVE, MEMORIAL DAY, INDEPENDENCE DAY, LABOR DAY, THANKSGIVING DAY, CHRISTMAS EVE, AND CHRISTMAS DAY and will be eligible to take an additional three (3) personal days. Full-time employees will earn three (3) personal days per year. Personal days are earned at the rate of one (1) day for each four (4) months i.e., four (4)

1 months = one (1) day: eight months = two (2) days and one (1) year = three (3) days. Personal days 2 are prorated for the first year of employment and are available as of 1/1 of the following year and 3 every year thereafter. Employees will be allowed to use a personal day provided the employee gives 4 three (3) days' notice, provided the request is in writing and using the Company form, of his intent to 5 use the personal day and there are no other scheduling conflicts or emergency situations. A personal 6 day may be used by an employee, if such use of a personal day is approved by the Company. Should 7 any of the foregoing scheduled holidays fall on a Sunday, the day observed by the Station shall be 8 considered as the scheduled holiday. An employee who is required to work on any of the foregoing 9 scheduled holidays as observed, shall receive two and one-half (2-1/2) times his regular straight time 10 rate (including all premium pay) for all hours worked and shall receive no additional time off. 11 Notwithstanding any other provision hereof, the Company may schedule or call-in employees to work 12 a shift of less than eight (8) hours on any of the foregoing scheduled holidays and in such cases the 13 employees will receive as a minimum, four (4) hours work or pay at the applicable rate.

E. The Company will make every reasonable effort to avoid requiring employees to work on a holiday, to the extent that such holiday observances do not interfere with the service which the Company believes is required. Employees not required to work on the above-mentioned holidays will be compensated for the day at eight (8) hours at straight time rate provided:

18 The employee who works his last scheduled workday preceding the holiday, and his first 19 scheduled workday following the holiday, except that an employee off on an excused absence for 20 reasons beyond the employee's control, shall be excused from complying with this requirement. Illness 21 that does not require hospitalization is not an excused absence. An employee scheduled and required to 22 work on a holiday who does not report for work shall not receive any pay for that day.

F. The Company will develop and enforce local overtime procedures. When overtime is contemplated, the Company and the Union will cooperate to the fullest extent possible to ensure their effectiveness. The supervisor on duty will determine the amount of overtime required to work, and the number of employees required.

G. The right of the Company to require overtime work is recognized, but the Company agrees to the extent practicable, to give consideration to the desires of an employee not to work overtime.

H. When an employee covered by this Agreement has been relieved for the day and i s recalled to work, he will be paid not less than three (3) hours at the overtime rate applicable for each call.

I. For continuous service before or after regular working hours, employees will not be required to go to work more than two (2) hours without being permitted a meal, and employees will be allowed a thirty (30) minute period in which to eat without loss of time.

- J. There shall be no pyramiding of the overtime rates provided for in this Agreement and no
 employee shall receive more than double time and one-half (2-1/2) the straight time rate for any hours
 worked.
 - K. It is the intent of the Company to provide as much notice of overtime availability as is practical.

2	WAGES
3	
4	A. The wage rates set forth in Schedule "A" attached here to and made a part hereof shall
5	prevail during the term hereof, as indicated.
6	B. No employee shall suffer any reduction in hourly rate of classification, including rates in
7	excess of those specified in the Agreement, as a result of this Agreement and nothing in this
8	Agreement shall be construed to prevent increases in individual rates of classifications over and above
9	minimums specified.
10	C. Should the regular payday fall on a holiday, the employees will be paid on the preceding
11	day.
12	D. Where there is a shortage equal to one or less of a day's pay, the employee will be
13	reimbursed for such shortages in his/her next regular paycheck. Should there be a shortage in excess of
14	one (I) day's pay, the employee will be reimbursed within the second business day, after notification,
15	as long as the shortage is due to the miscalculation or omission by the Company. The employee will be
16	responsible for his/her work time calculation.
17	E. Paychecks will include a statement of all hours, wages, adjustments and deductions for the
18	pay period.
19	F. Employees will be paid bi-weekly, on Friday. Employees whose regular day off is on a
20	payday, shall be given their paychecks before the end of their shift on the day before payday, if such
21	paychecks have been received. Providing the Company changes the payroll system, the Company will
22	consider the possibility of a weekly payroll system.
23	G. Employees leaving the service of the Company will be paid for all time due on the next
24	regular schedule payday (Friday). The employees agree to sign a payroll deduction authorization form,
25	authorizing the company to make deductions for company equipment not returned.
26	H. Any employee covered by this agreement who is required to travel by airplane for company
27	business shall be covered with a death benefit of \$17,500.00, which shall be awarded to the beneficiary
28	stated on the employee's insurance form.
29	I. Automatic changes in pay rates will be effective the day they occur and will be paid retro in
30	the following paid period.
31	J. The Company will not require employees to use their personal automobiles in the conduct of
32	Company business.

- K. The Company will not require employees to perform bargaining unit work during an FAA designated bomb scare.
- L. The Company shall notify the Union, in writing, the name, old rate, new rate, and amount of increase of all employees that receive a rate of pay in excess of the maximum rate of their job within five (5) days after such rate becomes effective.
- 6 M. The Company agrees to inform the Local Committee Chair promptly of all new hires and 7 terminations, through use of present forms, including the rate of pay. New employees will be 8 introduced by supervision to the Local Committee Chair promptly. The Company will notify the 9 Union, in writing, of all employees on extended sick or injury leave and of employee status change.

10 N. The Company is responsible for providing a designated area for storage of toolboxes as well 11 as providing reasonable security. Employees are expected to store their toolboxes in the designated 12 area. The Company will make available at no cost to mechanics and technicians, insurance coverage 13 against loss by fire or theft by break and entry of toolbox and contents owned by the employee while 14 such is on Company's premises in the designated secured area, for use in connection with employee's 15 work, and while in transit to or while being used in connection with a field service assignment. The 16 maximum coverage provided under such policy shall be \$6,000 per toolbox and contents with a fifty-17 dollar (\$50.00) deductible provision, subject to a maximum of three (3) toolboxes provided the 18 employee has completed an annual inventory and has notified the Company of any changes. Losses 19 under the policy will be settled by the insurance Company directly with the employee, with the 20 employee bearing the fifty-dollar (\$50.00) deductible amount. Each employee must provide the 21 Company with an inventory of tools on an annual basis and notify the Company of any addition to or 22 deletions from the inventory.

<u>ARTICLE 10</u> VACANCIES AND BIDDING

A. A vacancy shall be any job (permanent or temporary) which cannot be filled through an application of the seniority provision of this Agreement providing for the restoration of forces. A temporary vacancy will be defined as less than thirty (30) days in duration.

6 B. A temporary job shall be filled in accordance with seniority within the respective group 7 insofar as practical. In the event temporary assignment of work is necessary within a classification to 8 fill a temporary vacancy not involving a temporary promotion from a lower to a higher classification, 9 the assignment will be made in the reverse order of seniority insofar as practical and after such 10 assignment, the employee so assigned shall be returned to former job and status. When employees are 11 temporarily transferred from their regular work to work of another classification, they shall receive 12 their regular rate or the proper rate of the classification, whichever is higher, with a minimum of two (2) hours. It is recognized that this provision shall not be applied to create regular appointments of 13 14 temporary leads or inspectors.

15 C. Vacancies of more than thirty (30) days duration shall be bulletined through the company's 16 internal application system for a period of five (5) days, provided, however, that the Company shall 17 have the right to temporarily fill any such vacancies during such five (5) day period. Each bulletin shall state the approximate duration of job, number of jobs to be filled, type and class of each job, the 18 19 department, the basic rate of pay and/or premium rate for the job, and the date the successful bidder is 20 to report. An employee bidding more than one vacancy shall list his order of preference. The selection 21 of the successful bidder shall be by seniority plus ability to do the essential functions of the job, 22 satisfactorily perform the work and meet attendance standards. A successful bidder shall hold the job 23 to which assigned for a period of ninety (90) days as a trial period. This training period will involve 24 flexible scheduling through multiple shifts and is not subject to the bid process. In the event the job is 25 not as described or he did not demonstrate his ability to hold the job, he may be returned to his former 26 job and status. Notices indicating successful bidders must be posted within three (3) days after the 27 closing date of bid. An employee who revokes a bid after having been awarded the job shall not be 28 eligible to bid on an opening in the same job for a period of six (6) months.

D. In the event a vacancy in the classification covered by this Agreement exists in any department and no qualified employee bids, the Company may hire a new employee into the classification or department or shall have the right to select to fill such position with any qualified employee willing to accept such transfer. In the event no qualified employee is willing to accept the transfer, the Company may assign the least senior qualified employee.

1 E. In the event an employee is not selected as a successful bidder for a permanent job as 2 bulletined because the Company has determined that he is unable to perform the required work of the 3 job in a satisfactory manner, such employee may request a review of his qualifications. Such reviews 4 shall be made by a committee of four (4), two (2) selected by the Company and two (2) selected by the 5 Union. This committee may establish rules governing their procedure consistent with the provisions of 6 this Agreement. The employee will make his request known, in writing, not more than three (3) days 7 after the successful bidders are announced. The committee will have (5) days in which to complete and 8 issue its findings of their review, after receiving the employee's written request, and so inform the 9 Company and the Union whether or not the employee is qualified for the job he is seeking. If he is 10 found qualified, the Company will be obligated to place the employee on the job with seniority as of 11 the date specified. If the committee finds the employee not qualified, the determination is final and 12 binding. If the committee cannot reach a majority decision, a grievance may be filed omitting the verbal discussion steps of the grievance procedure. 13

F. All bids will be made in two (2) written copies, one (1) each to be furnished to the Companyand one (1) to the Local Chair.

1	<u>ARTICLE 11</u>
2	GRIEVANCE PROCEDURE
3	
4	A. For the purpose of this Agreement, the term "Grievance" means any dispute between the
5	Company and the Union, or between the Company and any employee, concerning the effect,
6	interpretation, application, claim of breach or violation of this Agreement.
7	B. Representation.
8 9	1. Representation for presentation and adjustment of disputes or grievances that may arise under this Agreement shall be:
10	(a) The Union will be represented by properly designated stewards, one for each
11	department or section thereof. In addition, the Union will be represented by a Local Union Committee
12	of not more than three (3) members, one (1) of whom will be designated as Local Committee Chair.
13	Where there is more than one (1) location in a defined area, separate stewards may be designated.
14	(b) The Union will be further represented by an accredited representative of the
15	International Union for dealing with the Vice-President of the Company, or his designee.
16 17	(c) The Company will be represented at Chicago-O'Hare International Airport by
18	authorized officials who will be empowered to settle grievances or disputes.
19 20	(d) Accredited representatives of the Union will have access to the premises and the offices of the Company during working hours by appointment.
21	(e) It is agreed that the Company and Union will make every effort to keep to a
22	minimum the actual time spent in disposing of disputes or grievances.
23	(f) When the stewards or committeemen are required to leave their work for the
24	purpose of investigating, presenting and adjusting grievances, they will first notify their immediate
25	supervisor or other responsible supervisor, before leaving their work and will again report to him
26	upon their return. It is understood that grievances will not be processed in the presence of customers.
27	C. Individual grievances must be filed promptly after cause giving rise to the grievance is
28	evident, and no individual grievance will be valid if not filed within ten (10) workdays of the date the
29	employee knew, or could reasonably be expected to have known, of the grievance. The procedure for
30	presentation and adjustment of disputes, complaints or grievances that may arise between the
31	Company and the Union with reference to interpretation or application of any provisions of this
32	Agreement shall be:

Step 1: The grievance shall be taken up by the Shop Steward, or, in the case of a

department or section thereof for which there is no steward, a committeeman, the grievant and the
supervisor of the department involved. The supervisor shall give his answer to the grievance to the
Shop Steward and/or Committeeman within three (3) days following its discussion in this Step.

Step 2: If the grievance is not satisfactorily settled in Step I, the grievance shall be reduced in writing on a form identical to Schedule "B", signed by the aggrieved employee(s), and may be referred by the Local Union Committee to the Department Manager or his designated representative. The appeal must be made in writing within five (5) workdays after the Step I decision and the actual appeal must be presented at a hearing within seven (7) workdays from the date of appeal to Step 2. A written decision will be rendered by the Company within four (4) workdays after adjournment of the hearing.

11 Step 3: If the grievance is not satisfactorily settled in the preceding steps, the Union's President-12 General Chair, or his Chair, or his designee, may refer the matter to the Company's Vice President or 13 his designee. The notice of intent to appeal the matter to Step 3 must be made in writing within ten (10) 14 workdays after the Step 2 decision. The Vice President or his designee will meet with the Union's 15 President-General Chair, or his designee, at the earliest possible time, but not later than ten (10) 16 workdays after receipt by the Vice President, and endeavor to reach a settlement of the issues involved 17 in the matter appealed. If unable to resolve the issue, the Company shall issue a written decision setting 18 forth its position on the issue(s). In no event shall such written decision be issued later than five (5) 19 workdays from the date of the meeting.

Step 4: In the event the grievance is not satisfactorily settled in the preceding steps of the procedure, the Union shall notify the Company in writing within ten (10) days following the date of the Company's answer in Step 3, of its desire to process the grievance to arbitration in accordance with the provisions of this Agreement.

Notwithstanding the provisions set forth in the preceding portion of this paragraph C, it is agreed that grievances involving a discharge or disciplinary suspension shall be presented, in writing, in Step 2 of the grievance procedure within ten (10) days following the occurrence of the event giving rise to the grievance.

Grievances which are not presented within the applicable time limit shall be considered withdrawn. In the event the Company fails to give an answer within the applicable time, the grievance will automatically progress to the next step of the grievance procedure. It is understood and agreed that any of the time limits set forth in the grievance procedure may be extended by written agreement between the Company and the Union. D. Either party to this Agreement shall be permitted to call employee witnesses at each and every step of the grievance procedure. The Company, upon demand, will produce payroll and other records of the specific employee for the purpose of substantiating the contentions or claims of the parties, well in advance of the formal proceedings of the grievance procedure.

E. Necessary hearings and investigations shall, insofar as possible, be conducted during regular business hours and all stewards, local committeemen and witnesses necessary for a proper hearing or investigation, will be compensated at straight time rate for time spent attending such hearing or investigation. No employee shall suffer any loss of regularly scheduled time for attendance at any hearing or investigation.

10 F. Probationary employees shall not have recourse to the grievance procedure in the event of 11 discharge or suspension within the probationary period. No employee who has completed his 12 probationary period shall be discharged or placed on disciplinary layoff nor disciplined without a fair 13 hearing before a designated representative of the Company, other than the one bringing the complaint 14 against the employee. Suspension from the service of the Company pending the hearing, which shall 15 be prompt, shall not be deemed a violation of this rule. At a reasonable time prior to the hearing, such employee and his duly authorized representative will be apprised, in writing, of the precise charge and 16 17 give a reasonable opportunity to secure the presence of necessary witnesses. A written decision will be 18 issued within five (5) workdays after the close of such hearing. If the decision is not satisfactory, then 19 appeal may be made in accordance with Step 3 of the grievance procedure.

The Local Committee Chair or his designee will be notified immediately of such discharge or disciplinary layoff. If no one has been designated for a shift on which such should occur, such notification will be made when the Chair or designee is available.

G. If it is found that an employee has been unjustly suspended or dismissed from the service, such employee will be reinstated with his seniority rights unimpaired, and his service record cleared.

H. The grievance procedure and arbitration provided for herein shall constitute the sole and exclusive method of determination, decision, adjustment and settlement between the parties of any and all grievances as herein described, and the grievance procedure and arbitration provided herein shall constitute the sole and exclusive remedy to be utilized by the parties hereto for such determination, decision, adjustment or settlement of any and all grievances as herein defined.

I. It is agreed and understood that arbitration is a continuation and a part of the grievance
 procedure.

ARTICLE 12 ARBITRATION

A. In the event the Union or the Company submits a grievance to arbitration, in accordance with the arbitration provisions of Article 11, the Arbitration Board shall be selected according to, and shall be governed by, the following procedure.

7 The Board of Arbitration shall consist of three (3) members; one (1) appointed by the Union, 8 one (1) appointed by the Company and (1) selected by the parties from a standing panel of three (3) 9 impartial referees. The parties shall meet within fifteen (15) days after the Company's Step 3 decision, 10 and each side (Union and Company) shall then strike one (1) name each; the remaining name shall be the third member and Chair of the Arbitration Board. The dispute or grievance shall be presented to the 11 12 Board of Arbitration, and the decision of the majority of such members shall be final and binding upon 13 the parties to this Agreement and shall be complied with within five (5) working days after decision is 14 rendered.

15 It is understood and agreed that the Board of Arbitration shall have jurisdiction and authority 16 only to interpret, apply or determine compliance with the provisions of this Agreement. The Board 17 shall have no power to add to, detract from or to alter in any way the provisions of this Agreement.

18 Notwithstanding any other provisions of this Article, and only in cases of grievances involving 19 Article 13, either party may invoke the arbitration procedure upon twenty-four (24) hours written 20 notice. The parties shall waive the tripartite Board of Arbitration and meet within three (3) hours to 21 select an impartial arbitrator from the list of permanent arbitrators. The arbitrator shall hold an 22 arbitration hearing as expeditiously as possible, but in no event later than twenty-four (24) hours after 23 receipt of notice. The arbitrator shall render a decision within three (3) hours of the close of the 24 hearing. No continuance of the hearing may be allowed without the consent of both parties. Failure of 25 a party to appear shall not prevent the issuance of an award. The sole issue shall be whether the no-26 strike/no-lockout provisions have been violated. In the event the arbitrator finds that the activities of either employees, the Union or the Company, or any or all of them, are in violation of the no-27 28 strike/no-lockout provisions of this Agreement, or threaten violations thereof, he shall, as part of his 29 decision, specifically order that all normal operations be resumed at once and that any offender cease 30 and desist from any then current, continued or prospective violations of the no-strike/no-lockout 31 provisions of this Agreement. The award shall be final and binding upon the parties to this Agreement 32 and shall be complied with at once.

B. Each party shall bear its own expenses in connection with the arbitration proceedings and shall equally share the fee and expenses of the third member of the Arbitration Board and such other expenses as may be incurred by mutual agreement between the parties.

1	ARTICLE 13
2	STRIKE AND LOCKOUT
3	
4	A. During the life of this Agreement, and in accordance with the Railway Labor Act, there shall
5	be no strike, slowdown, sit-down, stay in, boycott, sympathy strike, picketing, work stoppage or any
6	other type of interference of any kind, coercive or otherwise, with the Employer's business by the

6 7 Union, any of its officers or representatives, or any individual employee; and further, the Union shall do 8 everything in its power to prevent its members, officers, representatives and employees, either 9 individually or collectively, from participating in any unauthorized strike, including, but not limited to, 10 publicly disavowing such action and ordering all such officers, representatives, employees or members 11 who participate in such unauthorized activity, to cease and desist from same immediately and to return 12 to work, along with such other steps as may be necessary under the circumstances to bring about 13 compliance with its order. In cases of unauthorized activity described herein, the Employer may impose 14 disciplinary measure or discharge the employees directly or indirectly involved. In consideration of the 15 foregoing, the Employer agrees not to lock-out or cause to be locked out any employees covered under 16 the provision of this Agreement.

ARTICLE 14 GENERAL AND MISCELLANEOUS

A. Should there be any change during the life of this Agreement in license requirements, all employees affected shall be given the length of time required by the governmental body demanding the license to obtain such license without change in status or pay. Any qualified employee, upon request, shall be furnished with a certificate of eligibility by the Company for presentation to the proper government agency for procuring FAA or FCC license.

B. Any employee leaving the service of the Company will, upon request to the Company, be
furnished with a letter setting forth the individual's qualifications (date of hire, classification, length of
service and rate of pay).

12 C. If new equipment is put into service by the Company, affected employees shall be given 13 every opportunity to become familiar with the new equipment without change of classification or rate.

D. All orders or notices to an employee under this Agreement involving a change in assignment, promotion, demotion, furlough and leave of absence, schedule changes, discharge or disciplinary action, shall be given in writing, a copy of which shall be given to the Local Committee Chair.

E. Non-bargaining unit employees, including supervisory employees, not covered by this Agreement, shall not perform bargaining unit work which will result in a covered employee losing regular or overtime pay, except when training or instructing covered employees, or in case of an emergency. It is agreed that the protection of Company and customer property against the elements may be considered an emergency.

F. Locked bulletin boards will be provided by the Company at locations mutually agreed upon,
marked "International Association of Machinists and Aerospace Workers," for posting of notices. G.
New employees shall be introduced to the Shop Steward on the first day of work.

G. Each employee covered by this Agreement will be furnished with a copy of this Agreement provided by Menzies within 60 days of ratification of this Agreement.

H. In the event of a death in his immediate family (see list below) a covered employee will be allowed up to three (3) days absence from work without loss of straight time pay. Satisfactory proof of eligibility for time off will be furnished upon request by the Company. Use of bereavement time is reserved for preparations of and or attendance to funeral or burial proceedings. Additional necessary time off without pay may be granted by request of the employee. Such permission will not be unreasonably withheld, but in no event shall a request for this purpose exceed an additional five (5) working days. Reasonable advance notice of such absences must be given, and satisfactory
 confirmation provided when requested by the Employer.

Ask a Nurse Program for on the job injuries – Any and all on the job injuries that are not an 19 emergency or which do not require eminent medical attention, the affected employee will participate in 20 the Company's "Priority Care 365/Ask A Nurse Program." The Union and the Company agree that this 21 program evaluates the emergency situation, provides immediate treatment information, provides self-22 care information for the affected worker, provides follow up care and aid if needed and increase 23 worker satisfaction. Once an employee reports an injury that is not an emergency or which does not 24 require eminent medical attention to his/her Manager/Supervisor and the employee requires first aid as 25 defined by OSHA 29 of CFR 1904.7 and then no further care is requested, there is no requirement to 26 call the PC 354 Nurse. The Employee will then need to utilize the Medical Refusal Form. If the 27 employee needs or requests medical care, his/her Manager/Supervisor will contact Ask a Nurse at 1-28 800-665-0836. The Employee is required to speak with the Nurse. The Nurse will complete an initial 29 medical assessment and derive at a disposition, self-care or medical care for the employee;

R. Both the Union and Company agree to comply with Menzies Equal Employment Opportunity (EEO) and Affirmative Action Policy.

32 S. GROOMING STANDARDS When the Company provides uniforms and personal protective 33 equipment (PPE) for use during the scheduled work shift, they must be worn in their entirety, without

substitution of personal clothing or articles and in accordance with the Company's uniform policy. All uniforms and personal protective equipment will remain the property of the Company. It is the employee's responsibility to see that they are kept neat, clean and in good condition. Employees will be expected to reimburse the Company for their loss or abuse and agree to allow the Company to make payroll deductions.

5 T. Both Union and Company agree to comply with the Company's Social Media Policy. Employees are prohibited from posting videos made at any MENZIES AVIATION location or airport on 6 7 sites such as YouTube. Employees are prohibited from posting photographs which include the MENZIES 8 AVIATION logo or MENZIES AVIATION uniforms; unless specifically instructed, employees are not 9 authorized and therefore restricted to speak on behalf of MENZIES AVIATION; Employees may not publicly discuss clients, passengers, products, w h e t h e r confidential or not, outside company-authorized 10 11 communications. Employees are expected to protect the privacy of MENZIES AVIATION and its 12 employees and clients and are prohibited from disclosing personal employee and nonemployee information 13 and any other proprietary and nonpublic information to which employees have access. U. The Company agrees during the full term of this agreement to offer shift trading to eligible employees after ninety (90) days of employment and who are in good standing provided request is made with at least seven (7) days' notice (notice requirement may be waived in emergency situations where prior notice of need for shift trade is not known). More than two (2) lateness's in any quarter shall disqualify an employee from the attendance bonus herein for that quarter. An excused absence by the Employer shall not affect this eligibility. The attendance bonus is for the sole purpose of rewarding and encouraging employees to meet their work schedule and is not to be construed as condoning unexcused or excessive absences. Employees hired prior to January 15, 1999 must accrue one hundred (100) sick days prior to becoming eligible to participate in the attendance bonus program, however, once the employee has reached one hundred thirty (130) days, the one hundred thirty (130) day minimum will apply.

4. When such sick leave is granted, the number of days paid will be charged

against the number of days credited to an employee, and thereafter one (I) day for each month of
continuous service shall again be credited to the employee until the total credit again reaches one
hundred and thirty (130) days.

C. Employees will be required to request payment for non-occupational sick leave in writing not later than the pay period following their return to service, on a form to be provided by the Company. Such sick leave with pay will be granted only in cases of actual sickness. The Company may require a doctor's certificate before paying any request for sick leave.

D. All credit for non-occupational sick leave will be canceled if employment ceases for any purpose, and no payment for accumulated sick leave credit will be made at any time. No credit will be given for non-occupational sick leave purposes while an employee is on leave of absence.

E. When it is necessary for an employee to be absent from work because of occupational injury he will be covered by the State laws of Illinois in regard to being compensated for those days off due to such occupational injury.

F. An employee who suffers an injury arising out of and in the course of his employment shall not lose pay for his regularly scheduled hours on the day of such injury by reason of taking time off to receive medical attention or being ordered not to return to work by the doctor in attendance.

G. An employee who has twenty (20) years of service with the Company and retires or resigns will receive payment for sixty percent (60%) of his accumulated sick leave.

H. All employees calling off from work will do so two (2) hours in advance of their start time, if reasonably possible.

I. Employees covered under this agreement explicitly waive their rights under the Cook County sick leave ordnance and the current CBA will supersede the Cook County sick leave ordnance

- with the following exceptions (receiving medical care, or the victim of domestic violence or stalking,
 or a public health emergency closes work, school or daycare). Employer may request that employee
 provide supporting documentation.

2	INSURANCE BENEFITS

4	A. During the term of this agreement the Company will provide a medical/dental plan for all
5	full- time employees and their dependents who have met the eligibility requirements as defined by the
6	plan provided all necessary paperwork has been submitted within the applicable time frame. Employees
7	and their dependents are eligible to be covered under the plan on the 1st of the month following sixty
8	(60) days of continuous active employment. Should eligibility changes be mandated by the Health Care

Such leave or leaves may be 8 extended for additional periods not to exceed ninety (90) days upon appropriate application in writing 9 to the Company and union and approval in writing. An employee granted a leave of absence shall 10 retain and continue to accrue seniority during the first ninety (90) days, except where leave has been 11 granted because of health, injury or special assignment by the Company. Special assignment leaves in 12 the interest of the Company may be extended without approval by the Union.

B. Employees accepting full time employment with the Union as representatives of the
employees covered by this Agreement shall be granted an indefinite leave of absence by the Company.
An employee on leave of absence for this purpose shall retain and continue to accrue seniority.

C. Employees covered under this Agreement shall be granted time off without pay to attend to Union business, Union conferences and international conventions or other legitimate Union function, but to include no more than five (5) employees. Such request shall be made in writing, by the accredited full time IAM representative assigned to service the Agreement, or from the Recording Secretary of the Local Lodge.

D. The re-employment and seniority status of any covered employee who, while in the active service of the Company, enters the Armed Services of the United States, shall be governed by the provisions of the Uniformed Services Employment and Re-employment Rights Act of 1994, as amended, or other applicable legislative enactment.

E. The Company and the Union agree to follow the Company's Family and Medical Leave Act policy in accordance with Federal and State law. F. The Company and the Union agree to follow the Company's USERRA policy in accordance with Federal and State law. The re-employment and seniority of any covered employee who, while in the active service of the Company, enters the Armed Services of the United States, shall be governed by the provisions of the Uniformed Services Employment and Re-employment Rights of 1994, as amended, or other applicable legislative enactment.
