All Application Forms contain a statement of verification that must be executed by the Local Lodge financial secretary. This verification attests to a members good standing as of February 1, 2024. The Local Lodge seal must be imprinted on each submitted application. An application without the Local Lodge seal and financial secretary official signature will not be considered.

RULES AND REGULATIONS

AWARDS – The year 2024 awards will consist of one (1) first prize of \$3,750 and up to five (5) \$1,500 scholarships. Awards may be used for tuition only and will be paid directly to the United States-based accredited community college, university or trade or technical school at which the awardee is accepted.

ELIGIBILITY – The Essay Competition is open to members in good standing of District Lodge (DL) 142 as of February 1, 2024, who are not former recipients of a DL 142 Scholarship Award and to 2024 graduating high school seniors who are legal children of members in good standing of DL 142 as of February 1, 2024.

TIMETABLE – The Essay Competition will open Thursday, February 1, 2024, and will end at 11:59 p.m. MST, Sunday, ~~March 31, 2024~~ **extended to April 14, 2024**. Winners will be announced during the first week of May 2024.

ESSAY RULES – This year’s Essay subject is: **“THE IMPORTANCE OF UNIONIZING FOR THOSE NEWLY ENTERING THE WORKFORCE”**. The Essay must be: (1) Less than 1,000 words. (2) Must be printed on 8 ½ x 11 paper. (3) The title, only, must be placed at the top of the paper. (4) Entrant’s name or any other identifying marks will not appear on the Essay paper, but the Application Form. (5) A bibliography of sources for the essay material must be attached to the Essay. (6) All work must be the sole work of the entrant. To be considered, all Essay Rules above must be followed.

HANDLING – All Essays received become the property of DL 142 and may be printed in the future using the contestant’s name. Upon receipt, Essays and Application Forms will be separated and numbered only for judging purposes. The DL 142 Scholarship Committee will match winning Essays to the appropriate application. The winners will be screened by the DL 142 Scholarship Committee.

JUDGING – The judges will be selected annually by the DL 142 Scholarship Committee. They will be comprised of scholars and leaders who are not members of District Lodge 142. The decisions of the judges will be final. Essays will be judged on grammar, syntax, style, organization, and content.

DISQUALIFICATION – Entrants **must comply with all rules regarding the scholarship competition or be subject to disqualification**. Disqualification will be made by the majority vote of the Scholarship Committee and will be final and binding. Any information supplied by entrants found to be untrue will result in disqualification.

APPLICATION – **Fully completed** Application Forms **must accompany all Essays**. All applications must be sent by a common carrier (i.e., USPS, UPS, FedEx, etc.) to District Lodge 142, 9633 S. 48th St., Ste. 100, Phoenix, AZ 85044, and **postmarked no later than 11:59 p.m. MST, Sunday, ~~March 31, 2024~~ extended to April 14, 2024**.

The word “SCHOLARSHIP” must be written in the lower left-hand corner of the envelope used to send in all entries.
