**SUBJECT: DISTRICT LODGE 142 QUADRENNIAL CONVENTION – MARCH 17-20, 2025**

Dear Sisters and Brothers:

Pursuant to Article 4 of the Air Transport District 142 (District 142) Bylaws, a call is hereby issued for the Quadrennial Convention to be held in Las Vegas, Nevada. The convention will convene Monday - March 17, 2025 at 9:00AM at the Planet Hollywood Las Vegas Hotel, 3667 Las Vegas Blvd. S, Las Vegas, NV 89109. The nightly room rate is \$69.00, plus \$49.95 resort fee, plus tax.

Pursuant to Article 6 of the District 142 Bylaws, Convention Delegates shall be elected not later than the first monthly meeting in November or December of 2024. Please refer to the IAMAW Grand Lodge Constitution and the District 142 Bylaws for rules governing the nomination and election of Delegates. A copy of the District bylaws is enclosed with this mailing.

The Local Lodge Recording Secretary shall notify the District 142 Secretary-Treasurer no later than **December 19, 2024** of the names of the Delegates and Alternate Delegates of their Local Lodge. The link for Recording Secretaries to provide this information will be available on the District 142 website no later than November 1, 2024. Delegates may **not** submit their own information. The convention will be held Monday – March 17 through Thursday – March 20, 2025. Delegates should travel to Las Vegas on Sunday – March 16, 2025, and may depart after 3:00pm on Thursday – March 20, 2025 or any time on Friday – March 21, 2025.

Details for making hotel reservations and other necessary information will be posted on the District 142 website when they become available. **Please note:** the deadline for making hotel reservations is January 31, 2025, after which the group rate may not be honored. The hotel may apply a fee to reservations made over the phone.

In accordance with the District 142 bylaws, all lost time and expenses incurred by the delegates and/or alternate delegates attending the District 142 Quadrennial Convention will be borne by the respective Local Lodge. There will be a **\$100.00 registration fee per delegate** and voluntary donations of **\$40.00 to MNPL** and **\$10.00 to Guide Dogs of America**. The registration fee **must** be paid online, however the donations may be paid online or by personal check. No Local Lodge checks will be accepted for registration or donations.
