Good morning Sisters, Brothers, and Siblings,

Our committee has discussed the crucial need for legislative involvement at all local levels. Our local legislative committees must mobilize our members to ensure the passage of legislation that benefits labor and oppose legislation that harms it.

We recommend that all Machinists Locals increase communication with their local membership and share the following legislative committee recommendations.

- If your local does not have a legislative committee, start one. If you do have one, please make sure it is active and in communication with our MNPL Department.
- Locals should encourage increased individual contributions by promoting the importance of MNPL donations at meetings and events. Contributions can be made by signing up for payroll deductions, which we highly recommend, and also by using the MNPL donation QR code link, which can be posted at all Local meetings.
- Local Legislative Chairs should share the AFL-CIO scorecard for relevant politicians whose platforms focus on labor during their monthly meeting reports.
- Educate local Eboards on how to support and help fund legislative education while encouraging each member of your board to become a sponsoring member of MNPL at minimum.
- Encourage all locals to send delegates to the state AFL-CIO convention, get involved in AFL-CIO central labor, councils, and their areas, and participate in their state machinist councils.
