



OFFICIAL NOTICE **2026 GENERAL ELECTION**

In accordance with Air Transport District 142 Bylaws, a General Election will be conducted for offices of (1) President Directing/General Chair, (1) Secretary-Treasurer, (1) Vice President Alaska Airlines, (1) Vice President American Airlines, (1) Vice President Southwest Airlines, (1) Vice President McGee Air Services, (1) Vice President Hawaiian Islands, (3) Vice President At Large, (3) Trustees and (17) General Chairpersons. The term of office for the listed positions will be from January 12, 2027, until January 13, 2031. To nominate and/or have their ballot counted, a member must be in good standing of District 142. Members nominating/voting at the Local polling site must present valid photo ID, such as a state driver's license, company ID, military ID, passport, etc. Nominations for these offices can be made at a special meeting on **Friday, Sept 4, 2026**. In the event members of your Local nominate more than the allotted number per office, there will be an endorsement vote on **Friday, Oct 16, 2026**. Both the nomination and endorsement meetings will take place at the address listed in this mailer from **6:00 a.m. to 8:00 a.m.** and **6:00 p.m. to 8:00 p.m.** (Local time zones).

If the number of candidates that receive the endorsement of four or more Locals exceed the number of positions available:(1) President Directing/General Chair, (1) Secretary-Treasurer, (1) Vice President each- Alaska Airlines, American Airlines, Southwest Airlines, McGee Air Services, Hawaiian Islands, (3) Vice President At Large, (3) Trustees and (17) General Chairpersons, there shall be an election. The election, if necessary, will take place by secret ballot vote at the address listed in this mailer on **Friday, Dec 11, 2026, 6:00 a.m. to 6:00 p.m.** (Local time zones).

CANDIDATE ELIGIBILITY

All candidates for District Executive Board Office shall be members in good standing in the IAM for not less than one year and not less than one year of continuous good standing in District 142. All candidates must be working at the trade one year immediately prior to their nomination and free from any delinquencies of any nature to the Local, District, or the International (in accordance with the International Constitution). Candidates for carrier specific Vice President positions shall be employed by said carrier. Candidates for the Vice President At-Large positions shall be employed by any of the remaining companies represented by District 142 for which a specific VP position does not exist.

ABSENTEE NOMINATIONS/BALLOT

Members eligible to vote in the District 142 Election by absentee ballot are Members who: (1) reside more than 25 miles from the designated nominating/balloting place; or (2) are at work during the times of the Local nominations or balloting; or (3) are confined because of illness or injury; or (4) are on leave qualifying under family leave law; or (5) are working members on vacation or retirees more than 25 miles away from their residence on nomination, endorsement, or election days; or (6) are on official IAM business; or (7) are on employer travel assignment; or (8) are on military leave, may nominate or participate in the endorsement vote and election by absentee nomination form/ballot, upon request.

Members may also submit a request in writing using the attached form delivered by USPS mail or in person by the requestor to District 142 Secretary-Treasurer at Air Transport District 142 9633 S. 48th St., Ste. 100, Phoenix, AZ 85044-5643. The following provisions apply: (1) **the written request for an absentee ballot must be received by the District 142 Secretary Treasurer not later than 15 days before the election;** (2) the request must contain the members full name, current address, IAM card number (or employer and employee ID number); (3) the member must sign the request; (4) if the records of District 142 indicate that the applicant is eligible to vote in the election, the District 142 Secretary-Treasurer shall immediately mail the absentee ballot once ballots have been printed; (5) if, in the judgment of the District 142 Secretary-Treasurer, the member is not entitled to vote by absentee ballot, the member will be so notified, in writing, as soon as possible but no more than 5 days after receipt of the request for an absentee ballot.

Absentee nomination forms must be received by **September 4, 2026**. Absentee ballots for the October endorsement vote must be received to your Local election PO Box (included in your absentee ballot return envelope) by **October 16, 2026**.
