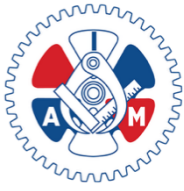

ABSENTEE NOMINATIONS AND ABSENTEE BALLOTS

Members who work more than 150 miles from their scheduled Local nomination meeting location, or who are scheduled to work or travel for work on the nomination, endorsement, or election dates, may request absentee nomination and absentee ballot materials.

Important Deadlines:

- Absentee Nomination Forms must be received by **September 4, 2026**.
- Absentee Ballots for the endorsement vote must be received by **October 16, 2026**.
- Absentee Ballots for the election must be received by **December 11, 2026**.
